FISCAL NOTE

This amendment will have no net effect on General Fund appropriations and revenue and a balanced budget is maintained for fiscal year 1997-98 and fiscal year 1998-99.

SUMMARY

30 This amendment appropriates \$1,000,000 in fiscal year 1997-98 to restore the Tree Growth Tax Reimbursement program to 32 full funding. In each fiscal year of the 1998-1999 biennium \$500,000 is deappropriated from the Maine Economic Improvement 34 Strategy.
