COMMITTEE AMENDMENT "A" to S.P. 852, L.D. 2251, Bill, "An Act to Provide Health Insurance Benefits to Dwight Parsons"

Amend the bill in the emergency preamble by striking out all of the 3rd "Whereas," paragraph (page 1, lines 8 to 10 in L.D.)

Further amend the bill in section 1 by striking out all of the last sentence (page 1, lines 30 to 33 in L.D.) and inserting in its place the following: 'These benefits must be at least equivalent to the benefits available to other state employees on the date of his retirement.'

Further amend the bill by inserting after section 1 the following:

'Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

COMMITTEE AMENDMENT "A" to S.P. 852, L.D. 2251

Further amend the bill by inserting at the end before the summary the following:

**FISCAL NOTE**

<b>APPROPRIATIONS/ALLOCATIONS</b>		
General Fund	\$704	\$4,225

This bill includes a General Fund appropriation of \$704 in fiscal year 1999-00 and \$4,225 in fiscal year 2000-01 for the State Employee Health Insurance Program within the Department of Administrative and Financial Services to provide health insurance coverage for Dwight Parsons. This estimate is based on the current annual premium cost for health insurance for single coverage and includes the projected 25% increase in premiums.'

**SUMMARY**

This amendment clarifies the level of benefits to be provided to Dwight Parsons and adds an appropriation section and a fiscal note to the bill.
