10	This bill includes an Other Special Revenue funds allocation of \$500 in fiscal year 2000-01 for the New Century Program Fund
12	within the Maine State Cultural Affairs Council. The amount of dedicated revenues that will be collected for this fund can not
14	be determined at this time. The additional costs associated with administering the New Century Program Fund can be absorbed by the
16	Maine State Cultural Affairs Council utilizing existing budgeted resources.
18	The Maine Humanities Council, the Maine Historical Society
20	and the Maine State Archives will incur some minor additional costs to participate as members of the Maine State Cultural
22	Affairs Council. These costs can be absorbed within the existing budgeted resources of the respective agencies.'

26	SUMMARY
28	Consistent with the intent of the bill, this amendment creates the New Century Program Fund to be used to implement the
30	Maine Communities in the New Century Program established last year to enhance preservation of local cultural resources and
32	designates the Maine State Cultural Affairs Council as the entity responsible for administering the fund on behalf of all state
34	cultural agencies. The amendment also adds a fiscal note, an allocation section, an emergency preamble and an emergency clause

to the bill.
