HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to H.P. 1700, L.D. 2200, "Resolve, to Study the Impact of a Maine-based Casino on the Economy, Transportation Infrastructure, State Revenues and the Job Market"

Amend the amendment in section 2 in the 2nd line (page 1, line 27 in amendment) by striking out the following: "19" and inserting in its place the following: '20'

Further amend the amendment in section 2 in subsection 11 in the last line (page 2, line 21 in amendment) by striking out the following: "and"

Further amend the amendment in section 2 in subsection 12 in the 2nd and 3rd lines (page 2, lines 24 and 25 in amendment) by striking out the following: "be it further"

Further amend the amendment in section 2 by inserting after subsection 12 the following:

'13. The Executive Director of the Christian Civic League of Maine or the executive director's designee; and be it further'

Further amend the amendment by striking out all of section 11 (page 3, lines 16 to 32 in amendment) and inserting in its place the following:

'Sec. 11. Appropriations and allocations. The following appropriations and allocations are made.


