## STATE OF MAINE SENATE 121ST LEGISLATURE FIRST REGULAR SESSION

- 14 SENATE AMENDMENT "A" to H.P. 477, L.D. 647, Bill, "An Act 16 To Prohibit Personal Watercraft on Lake St. George in the Town of Liberty"
- Amend the bill by striking out everything after the title 20 and before the summary and inserting in its place the following:
- 22 'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted
  24 as emergencies; and
- 26 Whereas, this legislation prohibits the operation of personal watercraft on Lake St. George; and
- Whereas, passage of this legislation prior to the upcoming 30 boating season is of critical importance; and
- 32 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of 34 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 36 safety; now, therefore,
- 38 Be it enacted by the People of the State of Maine as follows:
  - Sec. 1. 12 MRSA §7801, sub-§35, ¶¶EE and FF, as enacted by PL 2001, c. 638, §5, are amended to read:
- 42 EE. Middle Branch Pond in the Town of Waterboro in York 44 County; er
  - 46 FF. Highland Lake or Woods Pond in the Town of Bridgton in Cumberland County if the personal watercraft is rented and does not display a decal identifying the rental agency that owns the personal watercraft.; or
