Initiative: Provides ongoing funds for the New Century Community Program to be administered by the Maine State Cultural Affairs Council. Any amounts unencumbered at the end of each fiscal year do not lapse but must be carried forward to be used for the same purpose.



This amendment reduces the General Fund cost of the bill by \$4,400,000 per year beginning in fiscal year 2004-05.
