Amend the amendment in Part X by striking out all of section 1.

Further amend the amendment in Part X by striking out all of section 3.

Further amend the amendment in Part X in section 4 in subsection 6 in the next to the last line (page 170, line 22 in amendment) by striking out the following: "\$10 \$60" and inserting in its place the following: '\$10'

Further amend the amendment in Part X by renumbering the sections to read consecutively.
