provision of law, the State Controller shall transfer \$1,500,000  
from the Office of Licensing and Registration, Other Special  
Revenue Funds account in the Department of Professional and  
Financial Regulation to the Emergency Services Communication,  
Other Special Revenue Funds account in the Public Utilities  
Commission no later than June 30, 2005. It is the intent of the  
Legislature that this transfer of funds may not result in an  
increase in fees assessed for this purpose.'
