SENATE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to H.P. 1420, L.D. 1919, Bill, "An Act To Make Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2004 and June 30, 2005"

Amend the amendment by inserting at the end before the emergency clause the following:

**PART FFFF**

**Sec. FFFF-1. Change to University of Maine System.**

Notwithstanding any law to the contrary, the University of Maine System may not reorganize, close or change the name of any campus, center, college or program without providing notification to the Legislature of the reorganization, closure or name change, and in on case sooner than the report by the Chancellor of the University of Maine System to the Legislature in 2005 pursuant to the Maine Revised Statutes, Title 20-A, section 10902-B.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.


**SUMMARY**

This amendment prohibits the University of Maine System from
