SENATE AMENDMENT "G" to COMMITTEE AMENDMENT "A" to H.P. 1420, L.D. 1919, Bill, "An Act To Make Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2004 and June 30, 2005"

Amend the amendment by inserting at the end before the emergency clause the following:

**PART FFFF**

**Sec. FFFF-1. Change to University of Maine System.**

Notwithstanding any other law to the contrary, the University of Maine System may not reorganize, close or change the name of any campus, center, college or program without obtaining the approval of the Legislature. The university may introduce legislation regarding the reorganization, closure or name change of any campus, center, college or program.'

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
