10	This bill repeals boards and commissions that failed to file an annual report of activities with the Secretary of State for
12	2002 and 2003. Additionally, this bill repeals boards and commissions that filed annual reports with the Secretary of State
14	indicating inactivity in the preceding 24 months. The boards and commissions designated to be repealed include the following:

18	2. Maine Committee for Global and Geographic Education;
