HOUSE AMENDMENT "J" to COMMITTEE AMENDMENT "A" to H.P. 6, L.D. 1, Bill, "An Act To Increase the State Share of Education Costs, Reduce Property Taxes and Reduce Government Spending at All Levels"

Amend the amendment in Part B in section 1 in that part designated "\$706-A." in subsection 7 in the 10th line from the end (page 13, line 9 in amendment) by inserting after the following: "that purpose." the following: 'The election must be held within 45 days of the submission of the petition.'

Further amend the amendment in Part C in section 1 in that part designated "\$5721-A." in subsection 1 in paragraph D in the 5th to 7th lines (page 14, lines 31 to 33 in amendment) by striking out the following: "appropriated as the local share of the cost of essential programs and services under Title 20-A, chapter 606-B," and inserting in its place the following: 'amounts appropriated'

Further amend the amendment in Part C in section 1 in that part designated "\$5721-A." in subsection 7 in paragraph B in the 11th line from the end (page 17, line 16 in amendment) by inserting after the following: "that purpose." the following: 'The election must be held within 45 days of the submission of the petition.'

Further amend the amendment in Part D in section 35 in that part designated "\$15671-A." in subsection 5 in paragraph B in subparagraph (4) in the 9th line (page 32, line 14 in amendment) by inserting after the following: "that purpose." the following: 'The election must be held within 45 days of the submission of the petition.'



HOUSE AMENDMENT "J" to COMMITTEE AMENDMENT "A" to H.P. 6, L.D. 1

Further amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

### SUMMARY

This amendment makes a technical correction to remedy language concerning local spending caps included in Committee Amendment "A." The amendment also adds language requiring that elections on referenda be held within 45 days of petition submission.
