COMMITTEE AMENDMENT "B to H.P. 35, L.D. 32

### **SUMMARY**

This amendment replaces the resolve and is the minority 4 report. The amendment requires that the Executive Director of the Legislative Council redistribute the unexpended funds of the 6 Health Care System and Health Care Security Board to the individuals and organizations that contributed funds to support 8 the board. It requires the executive director to issue a refund to each contributor that is proportional to the contributor's 10 share of the total budget of the board, except that if the calculated refund is less than \$1 no refund is required.

### **Fiscal Detail and Notes**

This legislation requires the Executive Director of the Legislative Council to redistribute the unexpended funds of the Health Care System and Health Security Board to the individuals and organizations that contributed funds to support the board. The costs associated with calculating a refund and issuing a payment to each contributor will be absorbed by the Legislature utilizing existing budgeted resources.
