#### SUMMARY

This amendment clarifies that the Commissioner of Environmental Protection may waive the licensing or certification requirement for asbestos abatement activities undertaken by persons licensed by the Oil and Solid Fuel Board who perform emergency repair, installation, removal or servicing of heating equipment in single-unit residential buildings.

## **Fiscal Note**

### **Fiscal Detail and Notes**

This legislation clarifies the authorization of the Commissioner of Environmental Protection to waive the asbestos abatement licensing and certification requirement for certain persons under certain circumstances. This may result in a reduction in dedicated revenue derived from the fees assessed for asbestos licensing and certification in an amount that can not be determined at this time.
