28	Further amend the bill in section 1 by striking out all of subsection 5 and inserting in its place the following:
30	<u>'5. Ensuring equitable treatment for persons with certain</u>
32	<b>disabilities.</b> If the commission establishes or approves one or more low-income assistance programs under subsection 2 or 3 that
34	result in similarly situated persons receiving different levels of assistance depending solely upon which transmission and
36	distribution utility service territory they reside in, the commission shall by rule establish an equitable-treatment program
38	consistent with this subsection.
40	A. The equitable-treatment program must be available to any
42	person who:
44	(1) Is eligible for benefits under the transmission and distribution utility's low-income assistance program established in accordance with subsection 2; and

48	(2) Provides documentation from a doctor that the person for health reasons needs an oxygen pump at least 8 hours each day.

The equitable-treatment program must be designed to ensure that the low-income assistance benefits provided 4 under this section to persons who gualify under paragraph A mitigate, to an extent that is reasonably equivalent in each transmission and distribution utility territory, electric 6 charges associated with the operation of an oxygen pump. 8 The commission may not reduce any assistance provided under any low-income assistance program established under subsection 2 in order to satisfy the requirements of this 10 paragraph. 12
- C.The commission shall establish an administratively14simple and inexpensive method of administering the<br/>equitable-treatment program.
- D.Reasonablecostsincurredbyatransmissionand18distributionutilityinimplementinganyprogramestablishedbythecommissionunderthissubsectionarejustand20reasonableexpensesforrate-makingpurposes.

#### SUMMARY

- modifies the This amendment language governing the 30 establishment of the equitable-treatment program. It removes the requirement that overall program benefits provided to low-income persons who use oxygen pumps be substantially equivalent 32 throughout the State. Since the low-income programs of the various transmission and distribution utilities are dissimilar in 34 many ways, that result might be difficult to achieve and conflict with the goal of establishing an administratively simple and 36 inexpensive program. The amendment provides that the program ensure that low-income assistance benefits mitigate, to an extent 38 that is reasonably equivalent throughout the State, the increased electric costs associated with the use of oxygen pumps. 40 The amendment also ensures that only persons eligible for benefits under the current programs would be eligible for the adjustment 42 provided under the equitable-treatment program.
