18 COMMITTEE AMENDMENT "A" to S.P. 297, L.D. 889, Bill, "An 20 Act To Create the County Government Capital Improvements Revolving Loan Fund"

Amend the bill by striking out the title and substituting 24 the following:

26 'Resolve, Directing the Intergovernmental Advisory Commission To
Establish a Working Group To Develop a County Government Capital
28 Improvements Revolving Loan Fund'

30 Further amend the bill by striking out everything after the title and before the summary and inserting in its place the 32 following:

'Sec. 1. Intergovernmental Advisory Commission to establish a 34 working group to develop a county government capital improvements revolving loan fund. Resolved: That the Intergovernmental Advisory 36 Commission established under the Maine Revised Statutes, Title 5, section 12004-I, subsection 75-C shall establish a working group 38 to examine the feasibility of, and develop an appropriate design 40 for, a county government capital improvements revolving loan fund that would be available for providing financial assistance to counties for the acquisition, design, planning, construction, 42 enlargement, repair, protection or improvement of public service infrastructure and capital improvement. The working group must 44 include representatives from the Maine County Commissioners Association, Maine Sheriffs' Association, Maine Jail Association, 46 Maine Registers of Deeds Association, Maine Governmental 48 Facilities Authority, Maine Municipal Association and others as determined appropriate by the commission; and be it further

Sec. 2. Report and recommendations. Resolved: That the Intergovernmental Advisory Commission shall report its findings under section 1 and recommendations, including suggested legislation if appropriate, to the joint standing committee of the Legislature having jurisdiction over state and local government matters no later than February 15, 2007; and be it further

Sec. 3. Authority to report out legislation. Resolved: That the joint standing committee of the Legislature having jurisdiction
over state and local government matters is authorized to report out legislation concerning the study under section 1 to the First
Regular Session of the 123rd Legislature.'

SUMMARY

This amendment replaces the bill and changes it to a 20 resolve. It directs the Intergovernmental Advisory Commission to establish a working group to examine the feasibility of, and develop an appropriate design for, a county government capital 22 improvements revolving loan fund that would make available 24 financial assistance to counties for construction and repair projects. The working group must include representatives from 26 associations of county commissioners, registers of deeds, sheriffs, jail administrators and municipal officers as well as 28 the Maine Governmental Facilities Authority. The working group shall report its findings to the joint standing committee of the 30 Legislature having jurisdiction over state and local government matters by February 15, 2007. The joint standing committee of the Legislature having jurisdiction over state and local 32 government matters may report out legislation. 34
