28	1-B. Aggravated cruelty to animals. A person is guilty of aggravated cruelty to animals if that person, in a manner manifesting a deprayed indifference to animal life or suffering,
30	intentionally, knowingly or recklessly:
32	A. Causes extreme physical pain to an animal;
34	B. Causes the death of an animal; or
36	C. Physically tortures an animal.
88	Violation of this subsection is a Class C crime. Notwithstanding Title 17-A, section 1301, the court shall impose a fine of not
