14	amendment) and inserting in its place the following:
15	'Sec. 5. Convene stakeholder group. Resolved: That the commissioner, with
16 17	respect to the parcel of land in Falmouth described in section 3, subsection 5, shall
18	convene a stakeholder group in order to seek a compromise on the sale of that parcel and the possible creation of an easement or easements. The stakeholder group consists of one
19	member of Portland Trails, one representative of the Town of Falmouth and one
20	representative of owners of the lots abutting the parcel of land. If the stakeholder group is
21	able to reach a compromise in accordance with this section, the commissioner may
22	execute the sale in accordance with the compromise reached. If the stakeholders are
23	unable to reach a compromise, the commissioner is authorized to transfer the property in
24	accordance with section 4; and be it further'
25	SUMMARY
26	This amendment replaces language in Committee Amendment "A", which gives the
27	right of first refusal to abutting lot owners to purchase a parcel of land in Falmouth, with
28	language directing the Commissioner of Administrative and Financial Services to
29	convene a stakeholder group in order to seek a compromise on the sale of that parcel and
30	the possible creation of an easement or easements.
