40	This bill eliminates the requirement for a referendum vote in a member municipality of a school administrative district or
42	community school district where the school board has voted to close an elementary school. A referendum vote could still be
44	triggered by a petition signed by 10% of the number of voters in the affected municipality who voted in the last gubernatorial
46	election.
