Sec. 2. Reports. Resolved: 10 That the Public Utilities Commission shall issue an interim report on the status of its inquiry pursuant to section 1 and any preliminary findings and 12 of the recommendations to the joint standing committee Legislature having jurisdiction over utilities and energy matters 14 by January 1, 2007. The joint standing committee may request additional interim reports from the commission as the joint 16 standing committee determines appropriate. The commission shall issue a final report of its findings and recommendations to the 18 joint standing committee by January 1, 2008.

This legislation includes an Other Special Revenue Funds allocation to the Public Utilities Commission of \$217,464 II. fiscal year 2006-07 and will require a projected allocation of \$115,501 in fiscal year 2007-08 to provide funds for one limited-period Utility Analyst position, required contractual services and general operating expenses to carry out the purposes of this act. The Public Utilities Commission has resources available to fund the allocation.
