An Act To Provide an Energy Emergency Relief Fund To Provide Assistance for Home Heating Fuel Costs for Residents of This State, for Gasoline Costs for Service Providers and for Heating Fuel for Health Care Services Providers

(EMERGENCY)

1 **Emergency preamble.** Whereas, acts of the Legislature do not become effective
2 until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** this legislation needs to take effect before the expiration of the 90-day
4 period in order to provide assistance in purchasing home heating fuel to residents during
5 the current heating season; and

6 **Whereas,** in the judgment of the Legislature, these facts create an emergency within
7 the meaning of the Constitution of Maine and require the following legislation as
8 immediately necessary for the preservation of the public peace, health and safety; now,
9 therefore,

10 **Be it enacted by the People of the State of Maine as follows:**

11 **Sec. 1. Appropriations and allocations.** The following appropriations and
12 allocations are made.

13 **MAINE STATE HOUSING AUTHORITY**

14 **Energy Emergency Relief Fund**

15 Initiative: Provides funds to supplement low-income home heating fuel programs, to
16 supplement mileage reimbursement for service providers, including, but not limited to,
17 those in meals on wheels programs and to supplement reimbursement for heating fuel for
18 health care services providers, including, but not limited to, nursing homes, residential
19 care facilities and community-based residential services providers.

25 **Emergency clause.** In view of the emergency cited in the preamble, this Act takes
26 effect when approved.
