COMMITTEE AMENDMENT "A" to H.P. 1391, L.D. 1985, Bill, "An Act To Make Revisions to the Maine Revised Statutes Relating to Agricultural Fairs"

Amend the bill in section 3 in §87 in subsection 2 in the 2nd and 3rd lines (page 8, lines 3 and 4 in L.D.) by striking out the following: "in breeding classes on male animals" and inserting in its place the following: 'on unneutered male animals over 6 months of age that are'

Further amend the bill in section 3 in §88 in subsection 1 in paragraph A in the first line (page 8, line 15 in L.D.) by inserting after the following: "certificate" the following: 'with the commissioner'

Further amend the bill in section 3 in §88 in subsection 2 in the 5th line (page 8, line 32 in L.D.) by striking out the following: "and counsel"

Further amend the bill in section 3 in §96 in subsection 12 in the first paragraph in the 3rd line from the end (page 14, line 8 in L.D.) by striking out the following: "facts requested are" and inserting in its place the following: 'information requested is'

Further amend the bill in section 3 in §97 in subsection 4 in paragraph J in the 3rd line (page 17, line 22 in L.D.) by striking out the following: "liquor" and inserting in its place the following: 'alcohol or other intoxicating substances'

8 **SUMMARY**

10 This amendment makes minor language changes for clarity. It  
corrects a cross-reference. It revises a provision relating to  
12 premiums paid on male animals. Current law makes a fair licensee  
ineligible for a stipend if that licensee offers or pays premiums  
14 in breeding classes on male animals that are not recorded in the  
books of record for their breed. This amendment revises the  
16 provision to makes a fair licensee ineligible for a stipend if  
that licensee offers or pays premiums on unaltered male animals  
18 over 6 months of age that are not recorded in the books of record  
for their breed.

The replacement of the Agricultural Fair Support Fund with the Fair Fund within the Department of Agriculture, Food and Rural Resources will require the transfer of Other Special Revenue Funds from one account to the other with no net impact to the department.
