At a minimum, the Executive Director of Dirigo Health shall contact the Maine State Federation of Firefighters, the Maine Municipal Association and each municipality in the State that is served by volunteer public safety personnel and provide information regarding the eligibility of volunteer public safety personnel for health insurance coverage through the Dirigo Health Program as individuals and the availability of subsidies for qualified individuals based on income.'
