### Fiscal Detail and Notes

This legislation establishes the Casino Veterans Fund within the Department of Public Safety, Gambling Control Board. It increases by 2% the tax paid by casino operators on net table game and slot machine income and deposits this money into the Fund. Other Special Revenue Funds revenue will increase by \$1,074,480 in fiscal year 2012-13 as a result. The bill includes an Other Special Revenue Funds allocation of \$1,074, 480 to the department to disburse grants to nonprofit corporations that support or assist veterans.
