SUMMARY

11 This bill provides a General Fund appropriation of \$1,000,000 in fiscal years 2013-14 12 and 2014-15 for the Department of Health and Human Services to serve individuals on 13 the waiting list for services under the MaineCare Benefits Manual, Chapter II, Section 29, 14 Support Services for Adults with Intellectual Disabilities or Autistic Disorder. It also 15 provides corresponding Federal Expenditures Fund allocations.
