An Act To Require That Motorcyclists Wear Helmets

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §13106-A, sub-§25, ¶A**, as corrected by RR 2011, c. 2, §12, is
3 amended to read:

4 A. A person operating a snowmobile on a snowmobile trail identified by the
5 Department of Agriculture, Conservation and Forestry, Division of Parks and Public
6 Lands as having been funded by the Snowmobile Trail Fund pursuant to section
7 1893, subsection 3:

8 (1) If the person is under 18 years of age, shall wear protective headgear ~~that~~
9 ~~conforms to the standards established under Title 29-A, section 2083, subsection~~
10 ~~3; and~~

11 (2) May not carry a passenger under 18 years of age on the snowmobile unless
12 the passenger is wearing protective headgear ~~that conforms to the standards~~
13 ~~established under Title 29-A, section 2083, subsection 3.~~

14 **Sec. 2. 12 MRSA §13157-A, sub-§13**, as enacted by PL 2003, c. 655, Pt. B,
15 §414 and affected by §422, is amended to read:

16 **13. Operating ATV without protective headgear.** ~~Notwithstanding Title 29-A,~~
17 ~~section 2083, a~~ A person under 18 years of age may not operate an ATV without
18 protective headgear.

19 A. A person who violates this subsection commits a civil violation for which a fine
20 of not less than \$100 nor more than \$500 may be adjudged.

21 B. A person who violates this subsection after having been adjudicated as having
22 committed 3 or more civil violations under this Part within the previous 5-year period
23 commits a Class E crime.

24 **Sec. 3. 12 MRSA §13157-A, sub-§14**, as enacted by PL 2003, c. 655, Pt. B,
25 §414 and affected by §422, is amended to read:

26 **14. Carrying passenger on ATV without headgear.** ~~Notwithstanding Title 29-A,~~
27 ~~section 2083, a~~ A person may not carry a passenger under 18 years of age on an ATV
28 unless the passenger is wearing protective headgear.

29 A. A person who violates this subsection commits a civil violation for which a fine
30 of not less than \$100 nor more than \$500 may be adjudged.

31 B. A person who violates this subsection after having been adjudicated as having
32 committed 3 or more civil violations under this Part within the previous 5-year period
33 commits a Class E crime.

34 **Sec. 4. 29-A MRSA §2062, sub-§8** is enacted to read:

35 **8. Helmets.** A person may not operate a motorcycle or be a passenger on or in a
36 sidecar attached to a motorcycle on a public way unless the person is wearing a protective
37 helmet that conforms with minimum standards of construction and performance as
38 prescribed by the American National Standards Institute specifications Z 90.1 or by the

1 Federal Motor Vehicle Safety Standard No. 218 for motorcycle helmets and the helmet is
2 properly secured to the person's head with a chin strap.

3 **Sec. 5. 29-A MRSA §2083**, as amended by PL 2009, c. 652, Pt. C, §5, is repealed.

4 **Sec. 6. 29-A MRSA §2120** is enacted to read:

5 **§2120. Operating a motorcycle without a helmet**

6 A person commits a traffic infraction for which a fine of not more than \$500 may be
7 adjudged if that person operates or is a passenger on or in a sidecar attached to a
8 motorcycle on a public way without wearing a helmet in violation of section 2062,
9 subsection 8.

10 **SUMMARY**

11 Current law requires persons under 18 years of age to wear a helmet when operating a
12 motorcycle or riding as a passenger on a motorcycle as well as persons operating under a
13 learner's permit or within one year of completing a driving test and any passengers.

14 This bill requires all operators and passengers of motorcycles on public ways to wear
15 protective helmets.

16 This bill also corrects cross-references.
