Resolved: That the Department of Transportation shall convene a task force to study issues concerning private railroad crossings throughout the State. The study must include at a minimum questions about private railroad crossings concerning liability, maintenance fees, license fees and public safety. The department shall invite the participation of no more than 2 representatives of each of the following: owners of property accessible only by private railroad crossings; railroad companies operating in this State; owners of railroad tracks subject to private railroad crossings, including the State; the Small Woodlot Owners Association of Maine; the Maine Forest Products Council; the Office of the Attorney General; and the Maine Trial Lawyers Association to represent the interests of members of the public who could be affected by limitations of liability. The task force shall review activities in other states to address the same issues. The department shall keep the members of the Joint Standing

#### Fiscal Detail and Notes

The bill includes a one-time Other Special Revenue Funds allocation of \$25,000 in fiscal year 2013-14 to the Department of Transportation to convene a task force to study issues related to private railroad crossings. Funds exist within this account to cover the allocation. However, other projects may be delayed to fund this study.

The additional costs to the Department of the Attorney General are expected to be minor and can be absorbed utilizing existing budgeted resources.
