1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 10 MRSA §1412**, as amended by PL 1985, c. 370, §1, is repealed.

3 **Sec. 2. 10 MRSA §1413, sub-§1-A**, as enacted by PL 2003, c. 151, §2, is
4 repealed and the following enacted in its place:

5 **1-A. ASHRAE standards.** "ASHRAE standards" means ASHRAE Standard 62.1-
6 2007, Ventilation for Acceptable Indoor Air Quality, ASHRAE Standard 62.2-2007,
7 Ventilation and Acceptable Indoor Air Quality in Low-Rise Residential Buildings, and
8 ASHRAE Standard 90.1-2007, Energy Standard for Buildings Except Low-Rise
9 Residential Buildings, and the subsequent standards for building ventilation and energy
10 conservation adopted by ASHRAE.
