COMMITTEE AMENDMENT " $\mathcal{H}$ " to H.P. 258, L.D. 383, Bill, "An Act To Increase Public Awareness Regarding School Budget Elections"

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

'Sec. 1. 20-A MRSA §1486, sub-§2, as amended by PL 2009, c. 571, Pt. QQQ, §2, is further amended to read:

15 2. Validation referendum procedures. The budget validation referendum must be 16 held on or before the 30th calendar day following the scheduled date of the regional 17 school unit budget meeting. The referendum may not be held on a Sunday or legal 18 holiday. The vote at referendum is for the purpose of approving or rejecting the total 19 regional school unit budget approved at the regional school unit budget meeting. The 20 regional school unit board shall provide printed information to be displayed at polling 21 places to assist voters in voting. That information is limited to the total amounts 22 proposed by the regional school unit board for each cost center summary budget category 23 article, the amount approved at the regional school unit budget meeting, a summary of the 24 total authorized expenditures, a statement that includes the total dollar amount and the 25 amount of the percentage increase or decrease of the total authorized expenditures as 26 compared to the total authorized expenditures in the budget approved and validated in the 27 previous school year and, if applicable because of action on an article under section 28 15690, subsection 3, paragraph A, a statement that the amount approved at the regional 29 school unit budget meeting includes locally raised funds that exceed the maximum state 30 and local spending target pursuant to section 15671-A, subsection 5.1

#### SUMMARY

This amendment, which is the minority report of the Joint Standing Committee on Education and Cultural Affairs, strikes and replaces the bill to require that the information provided by a regional school unit board, which must be posted at polling places during a budget validation referendum vote, must include a statement that includes the total dollar amount of authorized expenditures in the budget for the upcoming school year and the
