

## **Fiscal Detail and Notes**

This amendment reduces the bill's Fund for a Healthy Maine allocations by \$150,000 in fiscal year 2012-13 and by \$400,000 in fiscal year 2013-14, leaving Fund for a Healthy Maine allocations of \$264,014 in fiscal year 2013-14 and \$14,014 in subsequent years for the State share of reimbursement for smoking cessation products under the MaineCare program.
