### **SUMMARY**

4 This amendment repeals a provision relating to service of process on nonresidents in 5 the laws governing the Board of Counseling Professionals Licensure and repeals a cross-6 reference to informal conferences in the statutes of the Board of Licensure of Podiatric 7 Medicine, in order to conform those statutes to the repeal in Public Law 2011, chapter 8 286 of all other references to informal conferences in the laws governing the Office of 9 Professional and Occupational Regulation. 10
