COMMITTEE AMENDMENT "A" to H.P. 726, L.D. 1031

SUMMARY
This amendment replaces the bill with a resolve. It directs the Commissioner of
Health and Human Services to review the use of restraint and seclusion in state mental
health institutes and nonstate mental health institutions. The commissioner is required to
report the findings and recommendations of the review to the Joint Standing Committee
on Health and Human Services no later than November 1, 2014. The commissioner is
also required to invite members of the disability rights advocacy community to discuss
the findings of the report and possible policy changes no later than November 15, 2014.
