13 14	'Resolve, Directing the Attorney General To Report on the Status of Discussions on Domestic Violence on Tribal Lands'
15 16	Amend the resolve by striking out everything after the title and before the summary and inserting the following:
17 18	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
19 20	Whereas, recent federal legislation specifically addresses tribal issues involving violence against women; and
21 22	Whereas, coordination in procedures and services concerning domestic violence benefits the State as a whole; and
23 24 25	Whereas, prevention of and responses to domestic violence involving tribal members and domestic violence on tribal lands can benefit from a coordinated statewide approach; and
26	Whereas, additional time is necessary to prepare a report by January 2014; and
