'Sec. 5. Appropriations and allocations. The following appropriations and allocations are made.



Fiscal Detail and Notes

This amendment delays the effective date by removing the emergency preamble and clause from the bill. This delay shifts a one-time appropriation of \$155,500 from fiscal year 2013-14 to fiscal year 2014-15 and reduces the General Fund cost of the bill by \$500 associated with the per diem and expenses of Legislators for 2 meetings budgeted in fiscal year 2013-14 that will not happen.
