20 21 22 23 24	Current law authorizes the Secretary of State to issue a special restricted license to a person who is 15 years of age based on educational need or employment need. This amendment authorizes the Secretary of State to grant such a license under other conditions that the Secretary of State determines to be extenuating and not inconsistent with the interest of highway safety.
