COMMITTEE AMENDMENT "A" to S.P. 99, L.D. 261, "Resolve, To Initiate the Procedures To Request the United States Congress's Joint Committee on the Library To Replace a Statue in the National Statuary Hall Collection"

Amend the resolve by striking out the title and substituting the following:

'Resolve, Directing the Maine Arts Commission, the Maine Historic Preservation Commission and the Maine State Museum Commission To Study the Replacement of Statues in the National Statuary Hall Collection'

Amend the resolve by striking out everything after the title and before the summary and inserting the following:

'Sec. 1. Maine Arts Commission, Maine Historic Preservation Commission and Maine State Museum Commission to study replacement of statues in the National Statuary Hall Collection. Resolved: That the Maine Arts Commission, the Maine Historic Preservation Commission and the Maine State Museum Commission, referred to in this resolve as "the cultural commissions," shall study and develop recommendations regarding the potential replacement of one or both statues currently in the National Statuary Hall Collection in the United States Capitol, including the following:

1. The public's interest in replacing one or both statues contributed by Maine currently in the National Statuary Hall Collection;

2. The public's interest in installing the statue of Governor William King, which is currently in the National Statuary Hall, in the Maine State House for Maine's bicentennial in 2020;

3. The public's interest in reinstalling the statue of Governor William King in the National Statuary Hall after Maine's bicentennial if the statue is installed in the Maine State House for Maine's bicentennial;

4. The necessary procedures for accomplishing the replacement of the statues in the National Statuary Hall;

1 5. The necessary procedures for accomplishing installation of the statue of Governor
2 William King in the Maine State House and reinstallation of the statue in the National
3 Statuary Hall after Maine's bicentennial; and

4 6. The feasibility of accomplishing the tasks recommended by the cultural
5 commissions study as a result of this resolve, including potential costs and sources of
6 outside funding.

7 The cultural commissions may invite input from Legislators and state agencies in
8 fulfilling the requirements of this resolve; and be it further

9 **Sec. 2. Reporting date established. Resolved:** That the cultural commissions
10 shall report their findings, including recommendations and any recommended legislation,
11 to the Joint Standing Committee on Education and Cultural Affairs by January 15, 2016.
12 The Joint Standing Committee on Education and Cultural Affairs may report out a bill
13 relating to the subject matter of this report to the Second Regular Session of the 127th
14 Legislature; and be it further

15 **Sec. 3. Appropriations and allocations. Resolved:** That the following
16 appropriations and allocations are made.

27 **SUMMARY**

28 This amendment replaces the resolve and directs the Maine Arts Commission, the
29 Maine Historic Preservation Commission and the Maine State Museum Commission to
30 study the public's interest in replacing one or both statues contributed by Maine currently
31 in the National Statuary Hall Collection in the United States Capitol and the procedures
32 for and the feasibility of accomplishing that process. The commissions are required to
33 report their findings to the Joint Standing Committee on Education and Cultural Affairs
34 by January 15, 2016, and the committee is authorized to report out a bill related to the
35 subject matter of the report to the Second Regular Session of the 127th Legislature.

36 The amendment also adds an appropriations and allocations section.
