SENATE AMENDMENT "A" to S.P. 691, L.D. 1684, Bill, "An Act To Implement Certain Recommendations of the Task Force on School Leadership"

Amend the bill in section 3 in §13112 in subsection 4 in the first line (page 4, line 12 in L.D.) by striking out the following: "shall" and inserting the following: 'may'


Amend the bill by striking out all of section 5.

**SUMMARY**

The bill requires the Department of Education and the State Board of Education to provide certain services and resources to assist school administrative units that form a regional school leadership academy. This amendment allows the department and the board to provide these services. The amendment removes the appropriations and allocations section from the bill.

### Fiscal Detail and Notes

This amendment eliminates the General Fund appropriation of \$148,075 in fiscal year 2016-17 to the General Purpose Aid for Local Schools program within the Department of Education for one Education Specialist.III position and one Office Associate II position and related All Other costs associated with providing services and resources to school administrative units (SAU's) that form regional school leadership academies. This amendment provides that the department may provide those services and resources to local SAU's but does not require it to do so. The amendment also eliminates the General Fund cost to support the 2 positions in the 2018-2019 biennium which is estimated to be \$153,666 in fiscal year 2017-18 and \$159,481 in fiscal year 2018-19.

As amended, the cost to the Department of Education to provide the services and resources to local SAU's that form regional school leadership academies if it chooses to do so can be absorbed within existing budgeted resources.
