5	SUMMARY
6	This bill requires a person to register on the registry of sex offenders maintained by
7	the Department of Public Safety, Bureau of State Police, State Bureau of Identification
8	when that person is a teacher, employee or other official having instructional, supervisory
9	or disciplinary authority who is convicted of a Class D or Class C offense of gross sexual
10	assault, unlawful sexual contact or unlawful sexual touching and the victim, regardless of
11	the victim's age, is a student over whom that person has control. Class D sex offenses are
12	considered Tier I offenses, requiring the offender to register for up to 10 years, and Class
13	C sex offenses are considered Tier II offenses, requiring the offender to register for up to

25 years.
