Insurance from other sources. A credit union authorized to do business in this State may insure shares with a licensed private mutual share guaranty corporation to 9 facilitate the provision of member services to: 10 A. A registered dispensary or registered caregiver authorized under Title 22, chapter 11 12 558-C; B. A licensee authorized under Title 7, chapter 417; or 13 14 C. An employee of a registered dispensary, registered caregiver or licensee described 15 in paragraph A or B. 16 **SUMMARY** 17 This bill allows state-chartered credit unions to procure private insurance in lieu of share insurance from the National Credit Union Administration to facilitate the provision 18 of financial services to registered dispensaries or registered caregivers authorized under 19 20 the Maine Medical Use of Marijuana Act, to entities licensed under the Marijuana Legalization Act and to their employees. 21
