If a licensee or registrant employs tokens to account for revenue from games of chance operated under this chapter and if the licensee or registrant maintains direct control over the sale and redemption of the tokens and keeps accurate records of all tokens used, then the chief Gambling Control Unit may by rule alter or reduce the record-keeping requirements of subsection 1 to the extent that a licensee's the use of tokens renders those records unnecessary for adequate control of the licensee's or registrant's games.
