## Fiscal Detail and Notes

The bill provides an income tax exemption for certain out-of-state pensions and would result in a loss of General Fund revenue of \$392,000 in fiscal year 2018-19 and a loss of Local Government Fund revenue of \$8,000 in fiscal year 2018-19. The bill includes a General Fund appropriation of \$11,000 in fiscal year 2018-19 to the Department of Administrative and Financial Services to make programming changes to the income tax system.
