The amendment strikes the bill and instead requires the use of scoring criteria to evaluate a bid's economic impact on Maine's economy and state revenues for competitively bid service contracts expected to exceed \$100,000 in total value and competitively bid printing service contracts expected to exceed \$5,000 in total value. The amendment also provides funding to the Department of Administrative and Financial Services for costs associated with the amendment.
