11	Amend the resolve by striking out all of section 2 and inserting the following:
12 13	'Sec. 2. Task force membership. Resolved: That the task force consists of the following 10 members:
14	1. One member of the Senate, appointed by the President of the Senate;
15 16	2. One member of the House of Representatives, appointed by the Speaker of the House of Representatives;
17 18	3. One member who is a superintendent of a school administrative unit that contains a large school, appointed by the President of the Senate;
19 20	4. One member who is a superintendent of a school administrative unit that contains a small school, appointed by the Speaker of the House of Representatives;
21 22	5. One member who is a member of a school board of a large school, appointed by the President of the Senate;
23 24	6. One member who is a member of a school board of a small school, appointed by the Speaker of the House of Representatives;
25 26	7. One member who is a member of an urban school board, appointed by the President of the Senate;
27 28	8. One member who is a member of a rural school board, appointed by the Speaker of the House of Representatives;
29 30	9. The Executive Director of the Maine Education Association or the executive director's designee; and

The amendment adds one additional member, who is a representative of the Maine Principals' Association, to increase the task force 8 9 membership to 10 participants. Legislative Cost/Study

The general operating expenses of this study are projected to be \$1,750 in fiscal year 2017-18. The Legislature's proposed budget includes \$10,000 in fiscal year 2017-18 for legislative studies. Whether this amount is sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature. The additional costs of providing staffing assistance to the study during the interim can be absorbed utilizing existing budgeted staff resources.
