The Secretary of State's budget includes sufficient funds to accommodate one ballot of average length for the general

election in November. If the number or size of the referendum questions requires production and delivery of a second ballot, an additional appropriation of \$107,250 may be required.

## Fiscal Detail and Notes

The Legislature, the Department of Secretary of State and the Maine Commission on Governmental Ethics and Election Practices would likely realize future biennium savings if the frequency of Legislative elections is reduced. The amount and timing of these savings cannot be determined at this time.
