Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and Whereas, the 90-day period may not terminate until after the beginning of the next 3 4 fiscal year; and 5 Whereas, certain obligations and expenses incident to the operation of state departments and institutions will become due and payable immediately; and 6 7 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as 8 immediately necessary for the preservation of the public peace, health and safety; now, 9 10 therefore, Be it enacted by the People of the State of Maine as follows: 11 PART A 12 13 Sec. Notwithstanding any other provision of law, the State Controller shall carry forward any unexpended balance, after all financial commitments for salary, benefits, other obligations and budgetary adjustments have been made, in the Personal Services and All Other line categories at the end of fiscal year 2016-17 to the All Other line category in the next fiscal year in the Department of the Secretary of State, Administration - Motor Vehicles program, Highway Fund to be used for the automated overlimit routing, restriction management and permitting system to improve the efficiency and effectiveness of the department's operations.

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.
