An Act To Reduce the Annual License Fee for High-stakes Beano and To Allow the Passamaquoddy Tribe To Operate 50 Slot Machines in the Tribe's High-stakes Beano Facility

- 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and
- 3 **Whereas,** passage of this legislation is necessary to ensure the continued operation 4 of high-stakes beano gaming by the Passamaquoddy Tribe; and
- 5 **Whereas,** many jobs and the operation of an elderly assisted living center depend 6 upon high-stakes beano gaming; and
- 7 **Whereas,** this legislation needs to take effect before next year's license fee to 8 operate high-stakes beano games becomes due; and

9 Whereas, in the judgment of the Legislature, these facts create an emergency within 10 the meaning of the Constitution of Maine and require the following legislation as 11 immediately necessary for the preservation of the public peace, health and safety; now, 12 therefore,

- 13 Be it enacted by the People of the State of Maine as follows:
- 14 Sec. 1. 8 MRSA §1011, sub-§2-C is enacted to read:

2-C. Passamaquoddy Tribe eligible for license to operate slot machines. The
 board may accept an application from the Passamaquoddy Tribe for a license to operate
 50 slot machines at a gaming facility in Washington County at which high-stakes beano is
 conducted by the Passamaquoddy Tribe.

19 Sec. 2. 8 MRSA §1019, sub-§7, as amended by PL 2011, c. 417, §6, is further
 20 amended to read:

21 7. Statewide and county referendum; municipal vote. After January 1, 2011, any proposed casino or slot machine facility may not be issued a license unless it has been 22 23 approved by a statewide referendum vote and a vote of the municipal officers or 24 municipality in which the casino or slot machine facility is to be located, except that a commercial track licensed to operate slot machines on January 1, 2011 is only required, 25 26 as a condition to obtain a casino license, to receive approval to operate a casino by means 27 of a referendum of the voters of the county in which the commercial track is located. 28 Notwithstanding this subsection, the Passamaquoddy Tribe may obtain a license to 29 operate slot machines at a gaming facility in Washington County at which high-stakes 30 beano is conducted.

- 31 Sec. 3. 8 MRSA §1020, sub-§3, ¶A, as amended by PL 2011, c. 585, §8, is
 32 further amended to read:
- A. Except for slot machines used for training and educational purposes at postsecondary institutions as provided by section 1011, subsection 1-B, the total number of slot machines registered in the State may not exceed 3,000 3,050; and
- 36 Sec. 4. 8 MRSA §1035, as amended by PL 2011, c. 585, §10, is further amended
 37 to read:

1 §1035. Location of slot machines

2 Slot machines may be located only on the premises of a commercial track, the 3 premises of a casino, the premises of a gaming facility in Washington County at which 4 high-stakes beano is conducted by the Passamaquoddy Tribe or the premises of an 5 accredited postsecondary institution for the purposes of training and education under section 1011, subsection 1-B. For the purposes of this section, "premises of a commercial 6 7 track" means property owned by the person who owns the property on which a 8 commercial track is located and that is either within 200 feet of the outside edge of the 9 racing oval or, if the commercial track was owned by a municipality when a license to 10 operate slot machines in association with that commercial track was issued, within 2,000 feet of the center of the racing oval. 11

12 Sec. 5. 8 MRSA §1036, sub-§1, as amended by PL 2011, c. 417, §7, is further 13 amended to read:

1. Distribution for administrative expenses of board. A slot machine operator 15 licensed under section 1011, subsection 2 <u>or 2-C</u> or a casino operator that is a commercial 16 track that was licensed to operate slot machines under section 1011, subsection 2 on 17 January 1, 2011 shall collect and distribute 1% of gross slot machine income to the 18 Treasurer of State for deposit in the General Fund for the administrative expenses of the 19 board.

20 Sec. 6. 8 MRSA §1036, sub-§2, as amended by PL 2015, c. 493, §4, is further 21 amended to read:

22 **2. Distribution of net slot machine income from casino with commercial track** 23 **and from slot machines operated in conjunction with beano.** A slot machine operator 24 licensed under section 1011, subsection 2 or 2-C or a casino operator that is a commercial 25 track that was licensed to operate slot machines under section 1011, subsection 2 on 26 January 1, 2011 shall collect and distribute 39% of the net slot machine income from slot 27 machines operated by the slot machine operator to the board for distribution by the board 28 as follows:

- A. Three percent of the net slot machine income must be deposited to the General Fund for administrative expenses of the board in accordance with rules adopted by the board, except that of the amount calculated pursuant to this paragraph, the following amounts must be transferred annually to the Gambling Addiction Prevention and Treatment Fund established by Title 5, section 20006-B:
- 34 (1) For the fiscal year beginning July 1, 2011, \$50,000;
- 35 (2) For the fiscal year beginning July 1, 2012, \$50,000; and
- 36 (3) For the fiscal year beginning July 1, 2013 and for each fiscal year thereafter,
 37 \$100,000;

B. Ten percent of the net slot machine income must be forwarded by the board to the
Treasurer of State, who shall credit the money to the fund established in section 298
to supplement harness racing purses;

1 C. Three percent of the net slot machine income must be credited by the board to the 2 Sire Stakes Fund created in section 281;

D. Three percent of the net slot machine income must be forwarded by the board to the Treasurer of State, who shall credit the money to the Agricultural Fair Support Fund established in Title 7, section 91;

6 E. Ten percent of the net slot machine income must be forwarded by the board to the State Controller and except as otherwise provided in this paragraph credited to the 7 8 Fund for a Healthy Maine established by Title 22, section 1511 and segregated into a 9 separate account under Title 22, section 1511, subsection 11, with the use of funds in the account restricted to the purposes described in Title 22, section 1511, subsection 10 6, paragraph E. For the fiscal years ending June 30, 2010, June 30, 2011 and June 30, 11 2012, the amount credited annually by the State Controller to the Fund for a Healthy 12 Maine under this paragraph may not exceed \$4,500,000 annually and any funds in 13 excess of \$4,500,000 annually during these fiscal years must be credited as General 14 15 Fund undedicated revenue, and, for the fiscal year ending June 30, 2013, the amount 16 credited by the State Controller to the Fund for a Healthy Maine under this paragraph 17 is \$0;

F. Two percent of the net slot machine income must be forwarded by the board to the
University of Maine System Scholarship Fund created in Title 20-A, section 10909
and to the Board of Trustees of the Maine Maritime Academy to be applied by the
board of trustees to fund its scholarship program. The slot machine income under
this paragraph must be distributed as follows:

- (1) The University of Maine System share is the total amount of the distribution
 multiplied by the ratio of enrolled students in the system to the total number of
 enrolled students both in the system and at the Maine Maritime Academy; and
- 26 (2) The Maine Maritime Academy share is the total amount of the distribution
 27 multiplied by the ratio of enrolled students at the academy to the total number of
 28 enrolled students both in the system and at the academy;
- G. One percent of the net slot machine income must be forwarded by the board to the
 board of trustees of the Maine Community College System to be applied by the board
 of trustees to fund its scholarships program under Title 20-A, section 12716,
 subsection 1;
- H. Four percent of the net slot machine income must be forwarded by the board to
 the Treasurer of State, who shall credit the money to the Fund to Encourage Racing at
 Maine's Commercial Tracks, established in section 299;

36 I. Two percent of the net slot machine income must be forwarded by the board to the 37 Treasurer of State, who shall credit the money to the Fund to Stabilize Off-track Betting Facilities established by section 300, as long as a facility has conducted off-38 39 track wagering operations for a minimum of 250 days during the preceding 12-month 40 period in which the first payment to the fund is required. After 48 months of receiving an allocation of the net slot machine income from a licensed operator, the 41 percent of net slot machine income forwarded to the Fund to Stabilize Off-track 42 Betting Facilities is reduced to 1% with the remaining 1% to be forwarded to the 43 44 State in accordance with subsection 1; and

One percent of the net slot machine income must be forwarded directly to the 2 municipality in which the slot machines are located. 3 Sec. 7. 8 MRSA §1036, sub-§2-A, as amended by PL 2013, c. 118, §2, is further 4 amended to read: 5 2-A. Distribution from casino of slot machine income. A casino operator shall collect and distribute 46% of the net slot machine income from slot machines operated by 6 7 the casino operator to the board for distribution by the board as follows: 8 A. Twenty-five percent of the net slot machine income must be forwarded directly 9 by the board to the Treasurer of State, who shall credit the money to the Department 10 of Education, to be used to supplement and not to supplant funding for essential programs and services for kindergarten to grade 12 under Title 20-A, chapter 606-B; 11 12 B. Four percent of the net slot machine income must be forwarded by the board to the University of Maine System Scholarship Fund created in Title 20-A, section 13 14 10909 and to the Board of Trustees of the Maine Maritime Academy to be applied by 15 the board of trustees to fund its scholarship program. The slot machine income under this paragraph must be distributed as follows: 16 17 (1) The University of Maine System share is the total amount of the distribution 18 multiplied by the ratio of enrolled students in the system to the total number of 19 enrolled students both in the system and at the Maine Maritime Academy; and 20 (2) The Maine Maritime Academy share is the total amount of the distribution multiplied by the ratio of enrolled students at the academy to the total number of 21 22 enrolled students both in the system and at the academy; 23 C. Three percent of the net slot machine income must be forwarded by the board to the Board of Trustees of the Maine Community College System to be applied by the 24 board of trustees to fund its scholarships program under Title 20-A, section 12716, 25 26 subsection 1; 27 D. Four percent of the net slot machine income must be forwarded by the board to the Treasurer of State, who shall distribute the funds to the tribal governments of the 28 29 Penobscot Nation and the Passamaguoddy Tribe; 30 E. Three percent of the net slot machine income must be deposited to the General 31 Fund for administrative expenses of the board, including gambling addiction 32 counseling services, in accordance with rules adopted by the board; 33 F. Two percent of the net slot machine income must be forwarded directly to the 34 municipality in which the casino is located; 35 G. One percent of the net slot machine income must be forwarded by the board to the Treasurer of State, who shall credit the money to the Agricultural Fair Support Fund 36 established in Title 7, section 91; 37 38 H. One percent of the net slot machine income must be forwarded by the board to the 39 Treasurer of State, who shall credit the money to the fund established in section 298 40 to supplement harness racing purses;

1 I. One percent of the net slot machine income must be credited by the board to the 2 Sire Stakes Fund created in section 281; 3 J. One percent of the net slot machine income must be forwarded directly to the 4 county in which the casino is located to pay for mitigation of costs resulting from 5 gaming operations; L. Beginning July 1, 2013, 1/2 of 1% of the net slot machine income must be 6 forwarded by the board to the Treasurer of State, who shall credit the money to the 7 8 Maine Milk Pool, Other Special Revenue Funds account within the Department of 9 Agriculture, Conservation and Forestry to help fund dairy farm stabilization pursuant 10 to Title 7, sections 3153-B and 3153-D; and 11 M. Beginning July 1, 2013, 1/2 of 1% of the net slot machine income must be 12 forwarded by the board to the Treasurer of State, who shall credit the money to the Dairy Improvement Fund established under Title 10, section 1023-P. 13 14 If a recipient of net slot machine income in paragraph $D_{\overline{3}}$ H or I owns or receives funds from a slot machine facility or casino, other than the casino in Oxford County, a slot 15 machine facility operated by the Passamaquoddy Tribe or the slot machine facility in 16 Bangor, then the recipient may not receive funds under this subsection, and those funds 17 18 must be retained by the Oxford County casino operator. 19 Sec. 8. 17 MRSA §314-A, sub-§4, as amended by PL 2015, c. 24, §1 and 20 affected by §2, is further amended to read: 21 4. Term of license; fees. A license issued under this section is valid for a period of 22 one year. The annual license fee for a high-stakes beano license is \$50,000, except that 23 the annual license fee due in 2008 to 2016 is \$25,000. License fees may be paid in 24 advance in guarterly installments. All license fees must be paid to the Treasurer of State 25 to be credited to the General Fund. 26 **Emergency clause.** In view of the emergency cited in the preamble, this 27 legislation takes effect when approved. 28 SUMMARY 29 This bill authorizes the Department of Public Safety, Gambling Control Board to 30 accept an application from the Passamaquoddy Tribe to operate 50 slot machines at a gaming facility in Washington County at which high-stakes beano is conducted by the 31 32 Passamaquoddy Tribe. The bill raises the limit on the number of slot machines allowed in 33 the State by 50 to accommodate the slot machines that may be operated by the 34 Passamaquoddy Tribe. Slot machines operated by the Passamaquoddy Tribe would be subject to the oversight of the Gambling Control Board and subject to the same laws and 35 rules as other slot machines operated in this State. 36 37 It also reduces the annual license fee for high-stakes beano from \$50,000 to \$25,000 38 and allows the Passamaguoddy Tribe to operate 50 slot machines in the tribe's high-stakes 39 beano facility.
