Instead, the amendment provides for the issuance of emergency medical services registration plates for emergency medical services persons who are licensed by the Emergency Medical Services' Board and certified by the Director of Maine Emergency Medical Services within the Department of Public Safety. The amendment also strikes the contingent effective date in the bill and requires the Secretary of State to issue emergency medical services registration plates on or after January 1, 2018. The amendment also adds an appropriations and allocations section.

Fiscal Detail and Notes

The bill includes a one-time Highway Fund allocation to the Department of Secretary of State of \$8,452 in fiscal year 2017-18 to manufacture and issue registration plates for emergency medical services personnel. Highway Fund revenue is increased in fiscal year 2017-18 by \$4,000 and in fiscal year 2018-19 by \$6,000 as a result of the \$5 issuance fee for these plates.
