Moratorium ordinance. Notwithstanding any other provision of this chapter or 16 any other provision of law to the contrary, a municipality may adopt and enforce an 17 ordinance that establishes a moratorium on the location within 500 feet of the property 18 line of a preexisting public or private school of new facilities or expansion of existing 19 facilities where registered primary caregivers cultivate marijuana plants. This subsection 20 does not affect any permit that has been granted to a registered primary caregiver prior to the effective date of this subsection. 21 This subsection is repealed July 1, 2018. Any ordinances adopted pursuant to this 22 subsection are not authorized and are void after July 1, 2018. 23 Sec. 2. Authority to report out legislation. The Joint Standing Committee on 24 25 Health and Human Services is authorized to report out legislation relating to municipal 26 ordinances regarding the location of facilities where registered primary caregivers cultivate marijuana plants within 500 feet of a school to the Second Regular Session of 27 28 the 128th Legislature.' 29 **SUMMARY** 30 This amendment allows a municipality to adopt an ordinance establishing a moratorium on the location within 500 feet of a preexisting public or private school of 31 32 new or expanded facilities where registered primary caregivers cultivate marijuana plants. 33 Any ordinance adopted may only be adopted until July 1, 2018. Any ordinance adopted

may not affect permits or providers that have been approved prior to the adoption of the
