### SUMMARY

This amendment removes the authority granted in the resolve to the Commissioner of Administrative and Financial Services to sell or lease state property in Bangor and in Penobscot County Unorganized Territory. The amendment also adds language to the resolve regarding the property authorized to be sold or leased in Rockwood Strip Township to include a parcel of land of approximately 6.35 acres in addition to the parcel of 0.36 acre specified in the resolve.

#### Fiscal Detail and Notes

Proceeds from the potential sale or lease of these properties will generally be credited to the Department of Administrative and Financial Services, Bureau of General Services - Capital Construction and Improvement Reserve Fund. The proceeds of the sale of the Limestone property will be provided to the Maine School of Science and Mathematics. The proceeds of the sale of the Brookton Township property and a portion of the Rockwood Strip property will be credited to the Unorganized Territory Education and Services Fund.
