COMMITTEE AMENDMENT "A" to H.P. 760, L.D. 1030, Bill, "An Act To Amend the Laws Governing the Substance Use Disorder Services Commission"

Amend the bill in section 2 in subsection 3 in the last line by inserting after the following: "and workshops." the following: "The commission, based on its activities pursuant to this subsection, shall make recommendations relating to substance use disorder to the department and the Governor."

Amend the bill by inserting after section 3 the following:

'Sec. 4. Appropriations and allocations. The following appropriations and allocations are made.
